
The purpose of this letter is to inform you that the Town of Vail Community Development Department has approved an amendment to Special Development District No. 4, Cascade Village, to allow the expansion of a salon and spa within the Hotel Talisa (formerly known as the Vail Cascade Resort & Spa) located at 1300 Westhaven Drive. The amendment includes the addition of 639 square feet on the lower level of the hotel facing the existing swimming pool and terrace. The addition is proposed under an existing colonnade, and will result in no additional site coverage and no change to setbacks. No other changes are proposed with this application.











Conditions:

1. Approval of this development plan is contingent upon the applicant obtaining Town of Vail approval of an associated design review application.

Staff Planner Spence provided an overview of the project.

Gillette – asked to clarify the density of the project as related to the master plan.

Stockmar – asked to clarify an unidentified area within the project and inquired about final platting. Asked about the status of the proposed low road near the fire station and whether the road will be gated. Asked about utility corridor at south end of site.

Kurz – asked to clarify if plans have changed since last review including parking, and snow storage.

Representing the applicant, Will Hentschel with 359 Design provided a presentation.

Pratt – asked to keep presentation to only the revisions since last review.

Hansen – asked to clarify the controlled access at low road. Asked if the Town of Vail will install the common amenities or how that will otherwise be handled.

Spence – asked to clarify how development of site amenities will be handled in relation to the HOA.

Pratt – asked how the project will be managed and if there will be on-site management.

Gillette – asked how other town projects have been managed.

Ruther - clarified Lion's Ridge Apartments is approximately 20 DU/acre

Public comment – There was no public comment.

Commissioner comments:

Hansen – Offered comments in support of the project.

Kurz – Offered comments in support of the project.

Gillette – Does not believe the site will be developed to its full potential. Project proposes 32 units where 62 units are specified so the density is half of what is specified in master plans including Housing 2027 and Vail 2020. Commissioner Gillette does not support the project.

Stockmar – Offered comments supporting project, but thinks it will be underdeveloped for town housing needs.

Pratt – Offered comments in support of the project while concurring with comments by Commissioners Gillette and Stockmar regarding density. Feels the project management and HOA creation needs additional planning but is overall supportive of the project.

Commissioner Stockmar left the meeting after voting on this item.

 A review of the results of the Plan4Health project. The Eagle County Healthy Communities Coalition was awarded the Plan4Health Grant in 2015. As part of this process, The Town of Vail received a comprehensive policy scan of planning documents as they related to healthy eating and active living. Pratt – asked to clarify if the PEC is being asked to provide a recommendation to the Town Council to join the coalition.

Hansen – asked to clarify the cost of town membership.

- Develop a strong public education effort in order to stimulate discussion and understanding about the visual arts.







Public Art Selection Parameters

Artwork Criteria:

- <u>Quality and Innovation</u>: The consideration of highest priority is the inherent artistic excellence and innovation of the artwork.
- <u>Timelessness</u>: Each artwork should be viewed as a long-term acquisition that should have relevance aesthetically to the community in future years. Due to the high visibility of public art by residents and guests who frequent public places, artworks should be selected that reflect enduring artistic quality.
- <u>Compatibility with Site</u>: Works of art should be compatible in style, scale, material, form, and content with their surroundings, and should form an overall relationship with the site.
- <u>Permanence</u>: Works of art shall have structural and surface soundness, and be resistant to theft, vandalism, and weathering. Artworks shall not require excessive maintenance or repair costs. Artworks that require frequent maintenance are discouraged.
- <u>Public Safety</u>: Artwork shall not create inordinate safety problems or liability problems for the general public or Town of Vail.

TRIP NOTES

Purpose

The purpose of this chapter is to establish guidelines, procedures and standards for the integration of public art into development projects in the town. The enhancement of public places by integrating the creative work of artists improves the pedestrian experience and promotes vibrancy, creativity and livelihood in the community. The presence of and access to public art enlivens the public areas of buildings and their grounds and makes them more welcoming. It creates a deeper interaction with the places where we live, work, and visit. Public art illuminates the diversity and history of a community, and points to its aspirations for the future. A wealth of art and culture in the public realm will foster the economic development of the community. (Ord. 8(2008) § 4)



Applicability

This chapter shall apply to projects that have a public art component in the approved development plan, as part of a special development district or an exterior alteration or modification in the public accommodation (PA), public accommodation-2 (PA-2), Lionshead mixed use 1 (LMU-1), Lionshead mixed use 2 (LMU-2) and ski base/recreation 2 (SBR2) districts. (Ord. 8(2008) § 4)



Public Art Requirements

Eligible Public Art:

The following, when produced in limited edition, shall be considered eligible as public art:

1. Attached or site integrated art elements such as passageways, bridges, street furniture, paving materials or artistic features within a garden;

- 2. Mosaics, painted murals, or terrazzo covering walls, floors and passageways;
- 3. Independent or freestanding sculpture;
- 4. Interdisciplinary artwork including the written word, glass, photography, sound, video or any other multimedia works of art appropriate for the site;
- 5. Earthworks or the integration of natural and manmade materials in the landscape;
- 6. Fountains and water features;
- 7. Works that are decorative, ornamental or functional elements of the architecture and that contemporary approaches sculpture, site furnishings, earthwork etc., are welcomed; or
 8. Any other project deemed eligible by the AIPPB.



Public Art Requirements

Ineligible Public Art: The following shall not be eligible as public art:

1. Reproductions or unlimited editions of original work;

2. Directional elements such as supergraphics, signage, or graphic elements already part of the project; or

3. Business or corporate logos or signage.



Public Art Requirements

Professional Artist: The public art project shall be designed by an artist that meets at least two (2) of the following criteria, provided that emerging artists who demonstrate a high level of competence, ability to create unique artistic enhancements, understanding of mediums and relationship of artwork to the site may be acceptable at the discretion of the AIPPB.

1. The artist has obtained a Bachelor of Fine Arts or Master of Fine Arts from an accredited college or university.

2. The artist has exhibition experience in a professional context (i.e., galleries, museum, art centers, or other exhibit venues).

3. The artist has received peer recognition such as honorable mentions, awards, prizes, scholarships, appointments, or grants.

4. The artist is pursuing his/her work as a means of livelihood and/or a way to achieve the highest level of professional recognition.

5. The artist's work has been discussed in a published writing.

6. The artist's artwork has been held in public or private collections.

TOWN

Public Art Requirements

Location:

Public art shall be installed in a location that is open to the public and is visible from a pedestrian or vehicular way. Locations include, but are not limited to, community hubs or gathering places, portals, entrances or gateways, adjacent to sidewalks, adjoining parks and plazas, integrated into the floors, walls and ceilings within public areas and high traffic areas or areas along a bus route. The public art shall be located on site unless otherwise permitted to use town owned property or right of way by the Vail town council. (Ord. 8(2008) § 4)
