Subject: 2019 Deed-Restricted Employee Housing Compliance Status Report

I. SUMMARY

The Town of Vail Housing Department is charged with verifying compliance of more than 888 deed-restricted properties in the Town of Vail, annually. As a courtesy, Housing staff sent affidavit forms to deed-restricted property owners on December 13, 2019 reminding each of their obligation to provide documentation demonstrating compliance by no later than February 1, 2020, per the terms of the recorded deed-restrictions.

As of June 2, 2020, 16 owners are non-compliant. Of those 16 owners, 15 were also non-compliant last year. The following owners are out of compliance with their Employee Housing Unit (EHU) deed restriction.
